Methods and materials for containment and cleaning up

- Spill** :

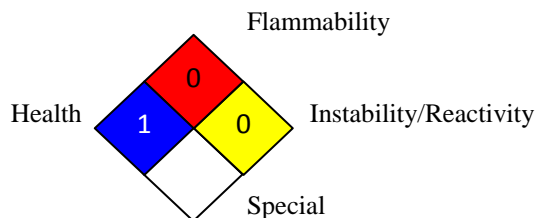
